



### **Catering Promotion 2018 Terms & Conditions**

1. The Promoter of this competition is Coupland's Bakeries Ltd trading as Coupland's Bakeries.

### **Method of Entry & Prize Redemption**

3. The competition commences at start of trade on the first day of each month and runs until close of trade on the last day of each month (i.e. April 1<sup>st</sup> 2018 – April 30<sup>th</sup> 2018).
4. Prize will be drawn by the 7<sup>th</sup> day of the following month.

To qualify to enter into the prize draw, simply complete a catering purchase with any participating Coupland's Bakeries Retail Store by filling in an order form or phoning your local store in advance. One x catering purchase = one automatic entry into the prize draw. Catering has to be paid for to be in the draw.
