

## Win Hot Laps with Greg Murphy Terms & Conditions

- 1. The Promoter of this promotion is Coupland's Bakeries Ltd trading as Coupland's Bakeries.

## Method of Entry & Prize Redemption

- 3. The promotion is "Win Hot Laps with Greg Murphy".
- 4. The promotion commences on 8/3/2021 and runs until close of trade on 4/4/2021.
- 5. To qualify to enter into the prize draw, purchase 2 x 6 pack Hot Cross Buns (any variety) at any participating Coupland's Bakeries Retail Store. One 2 x 6 pack Hot Cross Buns purchase = one entry form.
- 6. Hot Cross Bun Range includes: Traditional, Fruitless, Double Choc and Cranberry.
- 7. Entry into the competition is via an official entry form on the customers receipt footer that will be given out at time of valid purchase.
- 8. It is the customer's responsibility to place their entry forms into the designated entry form box in store.
- 9. Participants may enter as many times as they like with valid qualifying purchase.
- 10. No responsibility will be accepted for late entries.
- 11. To be eligible to win, you must
  - a. Have registered your details on an official entry form with qualifying purchase.
