

Coupland's Bakeries 50th Anniversary Celebration Super Sale Terms & Conditions

- 1. The Promoter of this promotion is Coupland's Bakeries Ltd trading as Coupland's Bakeries.
- 2. Entry into this promotion is deemed as acceptance of these and any other applicable terms and conditions. This promotion may have additional terms and conditions which wherever possible will be posted at <u>www.couplands.co.nz</u>

Method of Entry & Prize Redemption

- The promotion commences on Friday 2nd July 2021 and runs until close of trade on Thursday 29th July 2021 ("Promotional Period").
- 5. This promotion is open to Coupland's Bakeries customers shopping at Coupland's Bakeries stores in New Zealand.

- 7. Wholesale customers or Fundraising orders do not qualify for entry into the promotion.
