

## Coupland's Bakeries Cow & Gate Milk Ebikes Promotion 2021 Terms & Conditions

- 1. The Promoter of this promotion is Coupland's Bakeries Ltd trading as Coupland's Bakeries.
- 2. Entry into this promotion is deemed as acceptance of these and any other applicable terms and conditions. This promotion may have additional terms and conditions which wherever possible will be posted at www.couplands.co.nz

## **Method of Entry & Prize Redemption**

- 3. The promotion is "Cow & Gate Milk Ebikes Promotion 2021".
- 4. The promotion commences on Friday 1<sup>st</sup> October 2021 and runs until close of trade on Sunday 31<sup>st</sup> October 2021 ("Promotional Period").
- 5. This promotion is open to Coupland's Bakeries customers shopping at Coupland's Bakeries stores in New Zealand.
- 6. Wholesale customers or Fundraising orders do not qualify for entry into the promotion.

## **Prize Win**

- 7. To qualify to enter into the prize draw, customers must purchase at least 2 x Cow & Gate Milk 2L (any variety) in one transaction at any participating Coupland's Bakeries Retail Store. For every 2 x 2L Cow & Gate Milk 2L = one entry form.
- 8. Entry into the competition is via an official entry form that will be given out at time of valid purchase.
- 9. It is the customer's responsibility to register all details, including your full name, phone number & email address on an official entry form and place the form(s) into the designated entry form box in store.
- 10. Participants may enter as many times as they like with valid qualifying purchase.
