6. Wholesale customers or fundraising orders do not qualify for entry into the promotion.

7. To qualify to enter the prize draw, simply purchase 2 x 6pk Hot Cross Bun varieties during the 21st March – 17th April 2022 at any participating Coupland's Bakeries.
8. Entry into the competition is via an official entry form that will be given at time of purchase.
9. It is the customer's responsibility to register all details, including your full name, phone number & email address on an official entry form and place the form(s) into the designated entry form box in store.
10. Participants may enter as many times as they like with the valid qualifying purchase.
