- 6. Wholesale customers or fundraising orders do not qualify for entry into the promotion.

- To qualify to enter the prize draw, simply purchase 2 x 6pk Hot Cross Bun varieties during the 21st March 17th April 2022 at any participating Coupland's Bakeries.
